# Fulton County 4-H Volunteer Training Requirements

Ohio State University 4-H Volunteers have an outstanding reputation for their commitment to the development of our youth. In order to maintain this outstanding reputation, Ohio 4-H volunteers shall continue enhancing their skills to ensure all 4-H participants have a positive and educational experience by annually attending additional youth development training opportunities.

In accordance with this Ohio 4-H requirement, on an annual basis all current Fulton County 4-H Volunteers must attend at least two volunteer development trainings, totaling no less than two hours, on or before October 31 of the current year to remain active and in good standing. Trainings cover a wide variety of topics of interest and will be available at the county, region, State and national level. Each training must fit in one of the following areas: Communication, Organization, Program Management, Positive Youth Development, Education Design & Delivery or Interpersonal Characteristics. These trainings are required in addition to the Ohio State University Extension Recognizing & Reporting Child Abuse (Policy 1.50) training. At least one of the trainings must be an Extension provided, while the other may be an outside source training. Examples of acceptable events are included on the reverse.

Volunteers wishing to receive credit for an event offered outside of Fulton County 4-H will need to complete the Volunteer Training Form and submit it to the Extension Office. All trainings, with the exception of New Volunteer Orientation, must be completed during the current 4-H program year (Nov 1-Oct 31). It is the volunteer's responsibility to submit proof of attendance. Special exceptions may be presented to the Fulton County 4-H Educator for review. If a volunteer fails to complete their necessary trainings, their status as a 4-H Volunteer may be jeopardized up to and including immediate dismissal. Once removed from the list, one must reapply and complete the required screening process per OSU policy again to serve as a volunteer. Each case will be reviewed by the County 4-H Educator and a final decision rendered.
