

Camp Rules Agreement

I understand that I, _____ (Name of youth) will be expected to participate in all of the camp activities and follow the planned program. I agree that I am not to have or use any form of tobacco, alcoholic beverages, other drugs, or firecrackers while at camp. I also agree that camp is not a place for guns, knives, pornography, and Ouija boards, and I will not bring them to camp. I agree that I will not leave the campgrounds during the camp without the permission of the Camp Director. I will conduct myself with respect for others at all times and will cooperate with the camp staff. I understand that the cabin areas are restricted to boys in the boys' cabin area and girls in the girls' cabin area. I further agree to respect other people's property and camp property and agree not to deface or destroy camp property or use shaving cream or any other substance in a way which causes inconvenience to another camper. I understand that sexual harassment and physical intimidation are not allowed at camp.

I understand that 4-H Camp is a fun place to be for youth only when I respect other kids' rights and property and when other youth respect my right to enjoy camp and respect my clothing, personal property, and right to enjoy camp.

If I break any part of this agreement, I understand that my parents will be called immediately, and I will be sent home without a refund of my fees and at my own expense.

Further, I agree to allow the Extension Office to use my photo likeness for camp programs such as slide shows or power point presentations to enhance and promote the 4-H camping programs.
